Electronic bids must be submitted to Office of the Gauradaha Municipality, Gauradaha, Jhapa electronically through E-procurement section Web Site <a href="http://www.bolpatra.gov.np/epg">http://www.bolpatra.gov.np/epg</a> on before 12:00 hrs of 24th September 2023 (7th Ashoj 2080) and the bid opening shall take place at:14:00 hrs of 24th September 2023 (7th Ashoj 2080) on Gauradaha Municipality office, Gauradaha, Jhapa. Late bids will be rejected. Bids will be opened after bid submission deadline as mentioned above in the presence of representatives including bidders' (who choose to attend in person) at Municipality Office, Jhapa.

5. All bids shall be accompanied by a valid bid security of an amount not less than the amount as specified below. The bid security guarantee shall confirm to the standard format as specified in the bid document. The bid security guarantee issued by only the commercial bank approved by Nepal Rastra Bank shall be accepted by the employer. The bid security has to deposit in deposit account no: 37CA750361152401 of GAURADAHA MUNICIPALITY (Darauti Khata), Jhapa in NIC Asia Bank, Gauradaha, Jhapa.

6. Bids shall be valid upto 120 days.

7. Pre-bid meeting will be held in the office of Gauradaha Municipanty Office, Jhapa at 14:00 hrs on 14<sup>th</sup> September 2023 (28<sup>th</sup> Bhadra 2080). Detail Information about submission process of bid electronically (esubmission) shall be provided to all interested bidders who choose to attend this pre-bid meeting.

8. If the specified date for pre-bid meeting, last date of submission and opening falls on a Government holiday then the same time on the next working day shall be considered for such events. In such case the validity of bid security shall be considered from already specified last date for bid submission. Any intimidation, collusion and cartel ling during bidding process shall be punishable by law.

9. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
