

मदिरा नियन्त्रण नगर्न आदेश

रुकुम (पश्चिम) / उच्च अदालत सुर्खेतले रुकुम पश्चिममा मदिरा नियन्त्रण गर्ने निर्णय कार्यान्वयन नगर्न अन्तरिम आदेश दिएको छ । न्यायाधीश भानुभक्त शर्मा न्यौपाने र नारायणप्रसाद श्रेष्ठको संयुक्त इजलासले सो आदेश दिएको हो । जिल्ला समन्वय समितिको अगुवाइमा जिल्लामा मदिरा नियन्त्रण गर्ने अभियान चलेको थियो । जिससले मदिराको किनबेच र सेवनमा रोक लगाउने निर्णय गर्दै अभियान चलाएको थियो । सो निर्णय खारेजको

उक्त रिटमाथि भएको सुनुवाइपछि अदालतले निर्णय कार्यान्वयन नगर्न अन्तरिम आदेश जारी गरेको हो । अदालतले आन्तरिक राजस्व कार्यालयबाट इजाजतपत्र लिई मदिरा पसल सञ्चालन गर्दै आएको देखिँदा मदिरा पसलमा ताला लगाउने कार्य नगर्न नगराउन र ताला तथा सिलबन्दी लगाइएको भए तत्काल खोल्न निर्देशन दिएको छ ।

जिल्लामा ६ माघदेखि मदिरा आयात बन्द गरिएको थियो भने फागुन १६ गतेबाट मदिरा पसल बन्द अभियान चलाइएको थियो । जिससको निर्णयविपरीत भएको भन्दै प्रहरीले निवेदक पवन केसीको मदिरा पसलमा सिलबन्दीसमेत गरेको थियो । अदालतले गरेको अन्तरिम आदेशपछि जिल्लाका इजाजतप्राप्त पसललाई मदिरा व्यापार गर्ने बाटो खुलेको छ । जिल्लामा फागुन १६ गतेबाट मदिरा पसल बन्द थिए भने मदिरा कारोबार रोकिएको थियो ।

Bids must be submitted electronically on or before 12:00 Noon of 31st Day of publication (2076/01/04) of notice through E-procurement section of PPMO's Web portal <http://www.bolpatra.gov.np/egp> as specified in the Instruction to Bidders. Late bids will be rejected. Bids will be opened electronically at 2:00 PM on the same day of bid submission in the presence of the bidders or their representatives who choose to attend.
4. Pre-bid meeting will be held in the Gauradaha Municipality at 2:00 PM on 2075/12/22. Detail Information about submission process of bid electronically (e-submission) shall be provided to all interested bidders who choose to attend this pre-bid meeting.
5. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security mounting to a minimum of as described in details of work and issued by commercial bank, which shall be valid for 30 days beyond the validity period of the bid.
6. If the last date of purchasing, submission and opening falls on a government holiday, it shall be extended to the next working day. In such a case the validity of bid security shall be considered from already specified last date for bid submission.
